Use of land

The use of the land:

- Must maintain the surface of the capped area above the marker layer.
- Must reinstate the surface of the capped area above the marker layer if damaged or removed to the same condition or better.

Application requirement

An application to use land must be accompanied by a written report outlining how the proposal implements the Final Report Environmental Management Plan, Capped Area within Crown Allotment 2081, 107 to 125 Holdsworth Road, North Bendigo, 28 August 2013 and the Report Environmental Management Plan, Roadways and Fenced Area, 107 to 125 Holdsworth Road, North Bendigo, 26 September 2013, as appropriate.

Decision guidelines

Before deciding on an application, in addition to the decision guidelines in Clause 65, the responsible authority must consider, as appropriate:

- Whether the proposal is consistent with environmental management plans.

Buildings and works

Permit requirement

A permit is required to:

- Construct a building or construct or carry out works. This does not apply to:
 - Pathways, trails, seating, picnic tables, drinking taps, shelters, barbeques, rubbish bins, security lighting, irrigation, drainage or underground infrastructure.

- Playground equipment or sporting equipment, provided these facilities do not occupy more than 10 square metres of parkland.
- Navigational beacons and aids.
- Planting or landscaping.
- Fencing that is 1 metre or less in height above ground level.

Application requirement

An application to construct a building or construct or carry out works must be accompanied by a written report outlining how the proposal implements the Final Report Environmental Management Plan, Capped Area within Crown Allotment 2081, 107 to 125 Holdsworth Road, North Bendigo, 28 August 2013 and the Report Environmental Management Plan, Roadways and Fenced Area, 107 to 125 Holdsworth Road, North Bendigo, 26 September 2013, as appropriate.

An application to construct a building must be accompanied by the written consent of an environmental auditor appointed under Part IXD of the Environment Protection Act 1970.

Decision guidelines

Before deciding on an application, in addition to the decision guidelines in Clause 65, the responsible authority must consider, as appropriate:

- Whether the proposal is consistent with the environmental management plans.
- Whether proposal maintains the surface of the capped area above the marker layer.
- The effect of the proposal on nearby existing or proposed residential areas.
