**5.0 Maximum building height requirement for a dwelling or residential building**19/06/2014  
C187

A building used as a dwelling or a residential building must not exceed a height of 9 metres unless the slope of the natural ground level at any cross section wider than 8 metres of the site of the building is 2.5 degrees or more, in which case the height of the building must not exceed 10 metres.

In areas subject to the Special Building Overlay or the Land Subject to Inundation Overlay, the maximum building height may be exceeded by no more than the minimum additional building height required by the overlay provisions.

**6.0 Application requirements**19/06/2014

The following application requirements apply to an application for a permit under clause 32.09, in addition to those specified in clause 32.09 and elsewhere in the scheme:

- Plans showing existing vegetation and any trees proposed to be removed.
- Plans showing proposed landscaping works and planting including tree species and mature height.

**7.0 Decision guidelines**19/06/2014

The following decision guidelines apply to an application for a permit under clause 32.09, in addition to those specified in clause 32.09 and elsewhere in the scheme:

- Whether the proposal meets the preferred neighbourhood character statement and design objectives for the Precinct.

**8.0 Transitional provisions**14/05/2015  
C209

Schedule 2 to Clause 32.09 to the Neighbourhood Residential Zone does not apply to an application to construct or extend a dwelling or residential building made before the approval date of the planning scheme amendment that introduced this schedule into the planning scheme. The requirements of Clause 54 as they apply to Clause 54.03-2 or of Clause 55 as they apply to Clause 55.03-2 as in force immediately before the said approval date continue to apply.

Despite the provisions of Schedule 2 to Clause 32.09, these do not apply to an application under Section 69 of the Act to extend a permit to construct or extend a development.
