WONTHAGGI MOTOR RACING TRACK**Purpose**

To provide for the use or development of the Wonthaggi motor racing track and associated activities.

1.0**Table of uses****Section 1 - Permit not required**

Use	Condition
Apiculture	Must meet the requirements of the <i>Apiary Code of Practice, May 2011</i>
Bed and breakfast	No more than 6 persons may be accommodated away from their normal place of residence. At least one car parking space must be provided for each 2 persons able to be accommodated away from their normal place of residence.
Carnival	Must meet the requirements of ' <i>A Good Neighbour' Code of Practice for a Circus or Carnival, October 1997</i> .
Cattle feedlot	Must meet the requirements of Clause 53.08. The total number of cattle to be housed in the cattle feedlot must be 1000 or less.
Circus	Must meet the requirements of ' <i>A Good Neighbour' Code of Practice for a Circus or Carnival, October 1997</i> .
Crop raising (other than Rice growing and Timber production)	
Dependent person's unit	Must be the only dependent person's unit on the lot. Must meet the requirements of this schedule.
Dwelling (other than Bed and breakfast)	The lot must be at least 40 hectares. Must be the only dwelling on the lot. Must meet the requirements of this schedule.
Extensive animal husbandry Home based business Informal outdoor recreation Mineral exploration	
Mining	Must meet the requirements of Clause 52.08-2.
Minor utility installation Motor racing track Natural systems Railway Road	
Search for stone	Must not be costeaning or bulk sampling.
Timber plantation	The plantation must not be within 100 metres of: Any dwelling in separate ownership. Any land zoned for residential use.

Use of land

A lot may be used for one or more dwellings provided the following requirements are met:

- Access must be provided via an all-weather road to the satisfaction of the responsible authority.
- The dwelling must be connected to a reticulated sewerage system or if not available, the waste water must be treated and retained on-site in accordance with the State Environment Protection Policy (Waters of Victoria) under the *Environmental Protection Act 1970*.
- The dwelling must be connected to a reticulated potable water supply or have an alternative potable water supply with adequate storage for domestic use as well as for fire fighting purposes to the satisfaction of the responsible authority.
- The dwelling must be connected to a reticulated electricity supply or have an alternative energy source to the satisfaction of the responsible authority.

These requirements also apply to a dependent person's unit.
