Areas shown shaded on Map B – Proposed Works Area for the Widening of Narre Warren-Cranbourne Road from Princes Highway to Lansell Close, October 2001.	All native vegetation.
All land in a Public Acquisition Overlay or a Road Zone for the Pakenham Bypass.	All native vegetation provided the works are undertaken in accordance with a Project Environment Protection Strategy, which is consistent with the Minister’s Assessment under the Environment Effects Act 1978 for the Pakenham Bypass Project, to the satisfaction of the responsible authority.
All land in the area to which Schedule 1 of the Urban Growth Zone (Cranbourne West Precinct Structure Plan) applies.	All native vegetation which is shown as to be removed in a Native Vegetation Plan approved by the Department of Sustainability and Environment provided any conditions or requirements of the approved Native Vegetation Plan are met.
Land in Cranbourne East that is both:  bounded by Mayfield Road to the west, Berwick-Cranbourne Road to the south, the western boundary of the Cranbourne East Precinct Structure Plan to the east, and Linsell Boulevard to the north, and  Shown on the planning scheme maps as Urban Growth Zone (with no schedule number).	All native vegetation.
Land in a Public Use Zone 4 for the Lynbrook Railway Station and associated facilities.	Native vegetation required to be removed, destroyed or lopped to enable the land to be developed for the Lynbrook Railway Station and associated facilities.
