Transitional provisions

Schedule 1 to Clause 32.09 to the Neighbourhood Residential Zone does not apply to an application to construct or extend a dwelling or residential building made before the approval date of the planning scheme amendment that introduced this schedule into the planning scheme. The requirements of Clause 54 as they apply to Clause 54.03-2 or of Clause 55 as they apply to Clause 55.03-2 as in force immediately before the said approval date continue to apply.

Despite the provisions of Schedule 1 to Clause 32.09, these do not apply to an application under Section 69 of the Act to extend a permit to construct or extend a development.
